In his work, the author examines this aspect through the prism of the use of information systems that ensure accounting and control of the performance of official duties of civil servants. At the same time, it seems advisable to expand the range of proposed tools for evaluating employee performance through more effective and systematic mechanisms for monitoring the implementation of goals and the fulfillment of tasks assigned to government employees working remotely. In addition, among the management measures proposed by the author for the introduction of remote forms of employment in the public sector, special attention should be paid to the need for additional financial costs associated with monthly compensation payments. This aspect is justified by the provisions of paragraph 4 of Article 138 of the Labor Code of the Republic of Kazakhstan, according to which the employer is obliged to provide the employee with everything necessary for the performance of work duties, including equipment, informatization facilities, communication services and other means related to their installation and maintenance.
